BACKGROUND NOTE

According to Mahatma Gandhi every person should be provided with bare minimum necessaries i.e. food, shelter, and clothing. Gandhi is in favour of the self-sufficient village economy where the villages will be the independent economic units. For attaining smooth development of the economy, it is imperative to develop all the constituents of economy and society simultaneously. The overall progress of the entire economy depends on the balanced development of all the regions. Self-sufficient village economy is a bottom -up solution and in this context the role of institutions in the rural sector like the village panchayat and rural multipurpose co-operative can play a vital role. This understanding of Mahatma, is not just instrumental in realizing the goals of development but more importantly intrinsic in enjoying the same with a content approach in a sustainable manner. His ideals of truth as being 'non-hypocritical', non-violence as 'avoiding mental levels of violence too and not just physical violence' and satyagraha as 'passive resistance with love and compassion' are easy to read and write but difficult to understand in their full gravity.
